Dear Sir or Madam:

We write on behalf of Paramount Global companies Televisión Federal S.A. (“Telefe”) and Pluto Inc. (“Pluto.tv”) (Telefe and Pluto collectively referred to herein as, “Paramount”). As you may be aware, Telefe is the owner of certain exclusive intellectual property rights to the Argentine television series “Gran Hermano” as well as the “Gran Hermano” 24/7 live stream featured on Pluto.tv (the “Gran Hermano Content”).

We have recently learned that you are reproducing and distributing copies of the Gran Hermano Content online, including on various Twitch.tv channels, most recently at <https://www.twitch.tv/carpincholimpio1>, as well as at the following websites <https://carpinchotv.com/> and <https://carpincho.live/> without authorization. Moreover, you are promoting your unauthorized reproduction and distribution of the Gran Hermano Content on various social media accounts including Twitter at [https://twitter.com/carpincho\\_tv](https://twitter.com/carpincho_tv) and Discord Server CarpinchoTV (ServerID: 1047416232858636298).

We understand from your online postings you believe your activity constitutes a permitted fair use. We disagree that your activity qualifies as a legitimate fair use as your reproduction and distribution of the Gran Hermano Content constitutes substantial copying of the content. As such, your unauthorized use of Paramount’s copyrighted material constitutes, among other things, copyright infringement under the Copyright Act and counterpart laws worldwide.

While Paramount appreciates fans, critics and overall interest in its content, due to legal and contractual considerations, we are obligated to protect the intellectual property

rights relating to the Gran Hermano Content and protect against unauthorized copying and distribution of the content online.

As a result, we request you immediately cease all reproduction, distribution and promotion of the Gran Hermano Content on Twitch.tv, Twitter, Discord, or any other location where you are reproducing, distributing, or promoting the content, and refrain from doing so in the future. In addition, provide a written undertaking that you will comply with our demands. We trust that you understand Paramount's concern over the infringement of its rights and that you will cooperate fully with us without the need for further action.

Nothing in this letter shall be construed as a waiver or relinquishment of any right or remedy possessed by Paramount, or any affiliated party, all of which are expressly reserved.
